Disposable Carrier Bag Charge Report 2024

for the period 01 January 2024 to 31 December 2024

Since 3 July 2023, larger supermarket operators in Singapore with an annual turnover of more than S\$100 million are required to implement a minimum charge of 5 cents for each disposable carrier bag¹ provided to customers at their SFA-licensed supermarkets, under the Resource Sustainability Act 2019². The charge applies to disposable carrier bags of all material types.

As part of our obligations, Sheng Siong Group Ltd is required to publish information annually on the number of disposable carrier bags supplied, amount of proceeds collected, and how the proceeds are used, to ensure transparency and accountability in the use of the proceeds.

This report covers the period from 01 January 2024 to 31 December 2024 and complies with the requirements under the Resource Sustainability Act 2019 and the Resource Sustainability (Disposable Carrier Bag Charge) Regulations 2023.
